The Terms of Reference (TORs) of the Provincial Paigham-e-Aman Committee shall, inter alia, include the following -

TORs:

- Reinforce the national narrative by translating its core themes into locally credible language, platforms, and community engagement models suited to the social and sectarian realities of Khyber Pakhtunkhwa
- Design and implement awareness campaigns and outreach initiatives in collaboration with government, civil society, and media partners to widely disseminate the unified narrative, with a particular focus on youth and vulnerable communities

- c. Organize province- and region-specific Paigham-e-Aman activities, including ulema conventions, youth dialogues, inter-sect interactions, and peace campaigns that reflect local cultural and religious contexts.
- d. Serve as the principal forum for identifying local sensitivities, vulnerable districts, influential religious actors, and opportunities for preventive engagement.
- e. Liaise with the Information & PRs Department for media planning, public messaging, communication products, local campaigns and alignment of provincial / regional outreach with National Paigham-e-Aman Committee (NPAC) approved strategic direction.
- f. Regular reporting and feedback to NPAC to flag emerging tensions, hate trends, grievances and opportunities for timely intervention.
- g. Coordinator PPAC shall serve as member of National Committee, providing regular provincial and regional input into national deliberations and ensuring effective two-way coordination.
- h. Any other task(s) assigned by the Provincial Government of Khyber Pakhtunkhwa and/or National Paigham-e-Aman Committee from time to time.

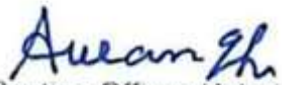
